



WIFA Water Conservation Grant Rebates

Avra Water Co-op (AWC) has been awarded a WIFA Water Conservation Grant. From the grant funds AWC will be offering reimbursement rebate checks for the replacement of High Efficiency or Dual Flush Toilets, Clothes Washing Machines, and Dishwashers. AWC encourages single-family customers to reduce their indoor and outdoor usage by installing these High Efficiency items that use less water and can help save you money on your water bill.

- High Efficiency Toilet Rebate - \$100 rebate per toilet. This rebate is limited to two toilets per household.
- High-Efficiency Clothes Washer \$250 for qualified washers. This rebate is limited to one clothes washer per household.
- High-Efficiency Dishwasher Rebate - \$150 rebate per household. This rebate is limited to one dishwasher per household.

Eligibility:

- Must be a single-family residential Avra Water Co-op member in good standing who meets the requirements stated below:

Requirements:

- Application must be completed by the AWC member with active water service at installation address.
- The new, high efficiency (1.28 gallons or less of water per flush) or dual flush (1.28/1.6 gallons per flush) toilet must replace an older, single flush, 1.6 gallon per flush or higher toilet.
- Applicant must provide a valid legible sales receipt dated April 3, 2024 or later. Receipt must include the rebate item purchased, purchase price, brand and model number of the qualifying high efficiency toilet, clothes washer or dishwasher.
- Include a picture of the old toilet, washer, or dishwasher and the newly installed toilet, clothes washer, or dishwasher.
- Households that have already reached the rebate limit will not be eligible for any additional grant rebates.

Please Note:

- Applications will be processed in the order they are received.
- All required documentation/pictures must be submitted to AWC before your application can be approved.
- If approved, a rebate check will be issued to you within 7 – 10 business days and mailed via U.S. Postal Service to the address on your application.
- **The Water Conservation Grant Rebate will continue until all grant funds have been expended or by 12/31/2025 (whichever comes first).**
